- Our insurance carrier will not insure any items shipped to foreign countries other than Canada. All foreign customers must make their own arrangements for insurance.
- Under no circumstances will we declare less value than the actual sale price on any shipments out of country.
- All legal disputes are settled in the State of Maine Court System.
- If you are late paying, picking up or taking delivery after 45 days after date of sale, it is important to note that any and all guarantees have expired and guarantee is not extended past the 45 days.
- Please allow 14-21 days from the time your payment is received for shipping.

Costs for shipping are:

- (a) SHIPPING CHARGE. The cost is right from the shipper's rate scales.
- (b) INSURANCE. We use an outside insurance company to insure packages and the charge for insurance is .75 per \$100 value; subsequently a \$200 item costs \$1.50 for insurance.
- (c) PACKAGING MATERIALS. To ensure safe arrival of your goods, we follow a stringent packing procedure. You are charged for all of the packing materials used including boxes, packing materials, and labeling materials.
- (d) LABOR CHARGE. Labor rate for shipping is billed at \$38.00/hour. A minimum charge is for fifteen minutes, and the labor charge begins at the time that the shipper begins to process your order including retrieval of goods from the warehouse, making boxes, packing, and preparing shipping invoices and logs.
