I, the undersigned, Lewis E. Yearout of 308 Riverview Drive East, Great Falls, Mentana, 5940I certify the following is true and correct:

I purchased Winchester Medel I895 rifle Serial ne.-44034 in Caliber .35 W.C.F. from Mr Phil Judd at the Kalispell Mentana Gun Show on March 3I, I979. The is a Deluxe Style "E" checking with Style No. 5 Factory engraving. Cost of engraving \$ I4.00 with inlaid gold band around breech of barrel. Arrived in the warehouse May 7, I904 and shipped May I0, I904. With shotgun hard rubber buttplate and with light pull.

I had viewed this specific gun several years earlier at Phil Judd's Sperting Goods store at 83 East Park Street, Butte, Mentana. According to Mr Judd at that time he did not wish to sell the gun, as he had taken it in trade from a good customer friend. That friend had used the gun in hunting untill he had consumed all of the .35 WCF cartridges he could find. Phil took the gun in trade for a new Weatherby rifle, scope and some ammunition. The friend visited his store at different times, and always was concerned that the gun remain in his safe and not be sold.

At the time the gun was purchased, Phil said he had to start selling some of his better guns as his health was not the best and he did not wish his wife to be left to sell some of the more valuable items, as she would not have any idea of correct values. In selling the gun he would not divulge the name of the previous owner for the above reasons.

Finally, Phil by letter of April I2, I980 did drop a letter with the owners name, but only after I promised I would not contact the owner for at least another year.

At the expiration of that year I did write the former owner -a Mr John Sconfienza who resided at Wise River, Montana. The former owner in a letter stated he azquired the gun in 1948, but he did not recall from whom he purchased the gun. He sold it to Phil Judd in 1977.


