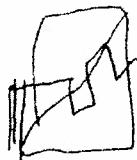

In reply to your letter dated May 15th, please be advised that due to the poor condition of our old shipping ledgers, company policy no longer permits inspection of these records.

We might add, that our records pertaining to the New Line models are incomplete and it is doubtful that sufficient data can be obtained from available records to assemble the book you plan to publish.

As noted in our letters dated May 13th, we are unable to provide historical information on New Line House pistol # 25287 and New Line revolver # 5345 as both weapons cannot be located in our records.

We've made a long and thorough search for historical information on Single Action Army revolver serial # 139380 and have been unsuccessful in locating the shipping record of this weapon.

We appreciate your interest in Colt firearms and we regret that we are unable to be of service to you in this instance.

Since we are unable to provide historical information regarding your old Colt revolver we are making arrangements with our Accounts payable department to return the remittance sent with your letter.

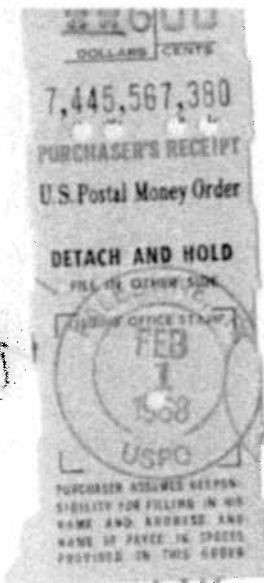
We regret we are unable to be of assistance to you at this time.
