


Elsie and I surely appreciate you and Elaine being so hospitable to us. Even with all the rush and work, it was a real pleasure to be with you. Many thanks for everything.





Smith Carbine: A fine example with 70% bluing and 40% case color intact. Wood is very nice with a few minor dings and is not refinished. Deep, clear markings and a crisp cartouche. Good bore. NRA fine. \$2,850.00

#### **HANDGUNS**

Marked Spiller & Burr Revolver: One of less than a handful known to have been marked with both "CS and Spiller & Burr." This is the first of two documented in Albaugh's book. All parts are stamped with serial # 104. The company of Spiller & Burr, located in Atlanta and later Macon, Georgia, manufactured about 760 of these .36 caliber revolvers, copies of the Whitney, between 1863 and 1864. Originally owned by Wm. Albaugh's neighbor and part historic Bond auction. A premier example of this Confederate handgun. \$45,000.00

Second Model LeMat Revolver: This is an all original and early second model LeMat. All serial numbers (1291) are matching. Patina is a nice even brown color with only very light peppering to metal from firing. A much sought after Confederate officers handgun in complete and factory correct condition. \$15,500.00


