Alphonse G. Capone (1899-1947) had one child, my grand father, Albert Francis "Sonny" Capone; he was born December 4, 1918, and died in Auburn, California, on July 8, 2007.

Albert Francis "Sonny" Capone had four children, all daughters, one of which is Diane Patricia Griesa, nee Capone, born January 14, 1944. Diane Patricia Griesa, nee Capone, a resident of California, is my mother.

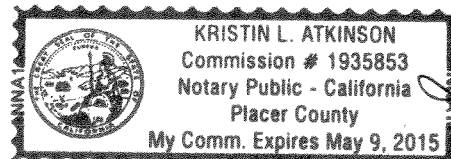

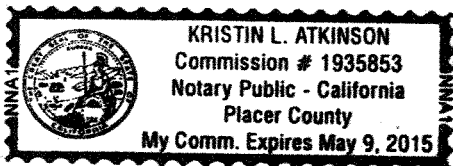
