Dear Mr. Yearout:

This is in reference to your two letters of February 15, 1979, and your subsequent letter of March 19, 1979, in which you requested that two Winchester "Trapper" carbines be considered for removal from the purview of the National Firearms Act (NFA).

As you are aware, we recognize that original Minchester "Trapper" carbines are desirable collector's items which merit consideration for removal from classification as NFA firearms. In the absence of any factory records which would establish the authenticity of these two "Trappers," we accept your statements and notarized documents as the best available means of authenticating these two firearms. Based upon the information which you provided and our additional research, we have determined that these two firearms are primarily collector's items and are not likely to be used as weapons. Therefore, the following firearms are removed from the purview of the NFA:

Winchester Model 1894 carbine, serial number 883055, caliber .30 W.C.F., with 15 inch barrel.

Winchester Model 1892 carbine, serial number 659700, caliber .44 W.C.F., with 15 inch barrel.

Further, we have determined that since these firearms derive a substantial part of their monetary value from the fact that they are novel, rare, or bizarre, they are also curios or relics as defined in Title 27, Code of Federal Regulations (CFR), Part 178, Section 178.11. Thus, licensed collectors may acquire, Mr. Lewis E. Yearout

hold, or dispose of them as curios or relics subject to the provisions of Title 18, United States Code (U.S.C.), Chapter 44, and Title 27, CFR, Part 178. They are still firearms as defined in Title 18, U.S.C., Section 921(a)(3).

Please note that in the case of any registered NFA firearms, which are removed from the Act, the owner should submit a written request to the National Firearms Act Branch, Washington, DC 20226, in order to amend the official records.

We appreciate your offer to assist in authenticating additional specimens and trust that we may call upon you for assistance should the need arise. However, we must recognize that in many instances it may not be possible for you to personally examine additional specimens which may come to our attention. For this reason, we would still appreciate any additional information, photographs, drawings, etc., which could aid in distinguishing authentic "Trappers" from modified rifles and carbines. We feel that this information could be of great benefit to all persons who have an interest in these firearms.

The Winchesters you inquired about are recorded, in the old serial number records, as follows:

Model 1876, serial number 3468, rifle, 24" octagon barrel, plain trigger, caliber .45-60. Shipped July 12, 1880.

Model 1894, 324611, rifle, caliber .30, 1/2 octagon barrel, plain trigger, take-down style, sporting rear sight, pistol grip and engraved for \$2.00. (Engraving not identified) Shipped April 26, 1907.

Model 1894, serial number 883055, no record. Our 1894 records go to number 353,999, the remainder up to number 1,643,000 have been destroyed.

Single shot, serial number 104843, rifle, caliber .25-20, 36" octagon barrel #4, double set trigger, Lyman combination front and rear sights, cup disc, plain pistol grip. Shipped May 3, 1907.

Single Shot, serial number 114,039, no record. Single Shot records in my file go to number 109,999, the remainder have been destroyed.

Model 1886, serial number 133200, rifle, caliber .45-70, 22" round mickel steel smokeless extra light weight barrel, plain pistol grip, shotgun butt rubber buttplate, take-down style, plain trigger, 4 cartridge magazine. Shipped August 28, 1909.

Model 1876, serial number 4529, rifle, caliber .45-60, 30" octagon barrel, set trigger. Shipped August 6, 1881.

Model 1876, serial number 53766, rifle, caliber .45-60, octagon barrel, plain trigger, 1/2 Magazine. Shipped May 14, 1886.

Single Shot, serial number 142, rifle, caliber .45-70, 28" octagon barrel, plain trigger. Shipped April 27, 1386.

Single Shot, caliber 101627, rifle, caliber .32-40, 30" octagon barrel, plain trigger. Shipped March 1, 1907.

Our records do not identify the original buyer or destination of the order.

The pictures as submitted are full length views of the left side, as on a Carbine this exposes the "Saddle Ring and Stud"—a highly desireable feature to any Carbine Collector. You will note on the Model 1873 Photo—It has two highly desireable features—seldom found on Carbines, that being not only the Saddle Ring and Stud, but also two Sling swivels. The Picture of the 1894 Carbine also features another scarce Collector feature—the 3/4 length magazine tubs.
