



Have had a little more time to go over your most welcome letter of the 17th inst. again and will expound on what has already been sent to you. First, it is hoped you were able to shoot a nice large elk. There is only a small herd of elk here in Pennsylvania and we are only allowed to look at them. Used to apply for a moose license in Maine but never got one. Have given it up as to get a 800 to 1200 pound animal out of the woods is a real tough job. Did shot one in Canada in 1968 and had to carry it out on our backs (had three others helping) - took two days.

Comments on your guns are:

4167 Cannot say with any certainty what the meaning of the S on the frame – it might indicate a movie rental company. This might explain the $7\frac{1}{2}$ " barrel.

5533 and 5549 Both great guns no matter who originally used them.
"Think" Kopec/Fenn claim them to be Custer guns. However,
no one knows the serial numbers of the Custer guns - all
are only guessing.

6154 and 7494 Even though no serial numbers are visible on the cylinders, the cylinders are probably original to these quns. From my experience, it seems the cylinder serial number was the first to go.

8793 The triggerquard serial number 8627 is included in the Factory records as being shipped commercially, shipped 7-8-1874 in a lot of 50 to S.H.&G.

There is nothing I can say about this pistol, you should just feel great that you have it.

This serial number is listed as being reshipped 7-1-1903 in a lot of 250 to Springfield Armory. Thus the date 1903 on the grip is correct. The frame for serial number 112911, number of backstrap for this gun, was reshipped 10-5-1901 in the 2nd lot of 50 to Springfield Armory. If you send the sub-inspector's initial(s) for the barrel and cylinder there may be more data that can be provided.

There is nothing I can add to this one except you have another good one for your collection.

Why this gun and the preceding one are/were not stamped U.S., I know not. I am inclined to agree with you but have no way to prove it. It just does not seem reasonable Colt's would fail to stamp U.S. on so many guns in this serial number range. Buybacks - the only recorded buybacks by Colt's are in the 92XXX- 96XXX serial number range. All others I believe were sold directly to dealers by the various states.

61259/61307 A wonderful history behind this gun. Wonder if the governor had 2 guns and someone cleaning them for him mixed up the parts. Have you advertised for or in any way tried to locate the frame #61307 to learn what was attached ot it? Had nothing here on these serial numbers until your letter arrived.

This gun was reshipped 6-16-1903 in a lot of 200. Thus the date on the grip is correct. The frame for the barrel number 47972 was reshipped 2-13-1903 in a lot of 150 to Springfield Armory.

112166 You are mighty lucky to have this one - none better that I know of.

This one was reshipped 7-24-1901 in a lot of 50 to Springfield Armory. The frame for the triggerquard #96034 was reshipped 2-13-1903 in a lot of 150 to Springfield Armory.

137674 Another of your great guns. Keep trying, you may be able to obtain the original grip yet.

The only civilian serial numbers of interest anymore are those under serial number 200. Have so many above this number I just can't handle any more of them. Please do not reveal where you obtained the shipping information in this letter. Do hope you and all yours had a great Thanksgiving Day.
