



I very much regret having to advise you that your new pair of guns have been delayed and whilst the reason may sound feeble it is genuine. Your guns were in the middle of being stocked when our stocker was taken ill and has since had a double Hernia operation. He will not be back at his bench to recommence work until mid January. As he had started the stocking I would not allow another workman to pick up were the first man left off hence we have wasted or lost time. I now expect completion late in May.

I do sincerely apologise for this delay and I hope it will not disappoint nor inconvenience you to much.

Due to pressure of work we will not, now, be attending The Shot Show in Atlanta but we do hope to show at a Gun Show in Las Vegas in either January or February 1986.

Firstly my apologies for my delay in formally acknowledging safe receipt of your 16 bore Holland & Holland Royal grade shotgun No. 30729. I trust that you received my telephone message of Friday last the 14th.

I would like to re-assure you regarding the re-case colouring of the action, I appreciate that my Brother David reassured you on the telephone but I would like to endorse his advice to you 100%.

The cost of the work required will be as follows:


- To strip down, prepare for and re-colour harden action and all parts. To free all working parts after hardening and to test.....£210.00
- To clean and hand burnish all inside mechanisms in locks, trigger housing, lever work and ejector forend. Rebluing trigger guard and top lever together with all pins and screws. To oil and grease and shoot to test.....£41.00
- To tighten and rejoin the loose action back onto the barrels.....£46.00
- To raise dents in both barrels, honing out to polish within Proof limits (which are tight see advice on page 2).....£22.00
- To polish off barrels, degrease and reblack best quality.....£40.00

We have taken the measurements of your Holland side lock stock and they are as follows:

BEND: 1 7/16" Comb X 2 7/16" Heel
 CAST: 7/32" Bump x 9/32" face x 1/8" comb x 3/8" toe.
 Length from single trigger: 14 1/16" Heel x 14" centre x 14 1/4" Toe.

These measurements do vary slightly from the measurements we have for your new pair of boxlock guns however, if you are happy with these measurements with the hollowed out cheek area please advise and we will copy them exactly.



N.B. The overall condition of your Holland is good. The action is rather loose but can be tightened and rejointed as per our quotation. The barrels, whilst being sound are, in the right bore, only just within proof measuring .668 and being out of proof once in excess of .669. We would not however, suggest reproofing at this point of time.


