





I have, this morning, packed and despatched your forend off gun No. 16048 by insured Air Mail. Please advise us when you receive same. Thank you.


I have waited until now before despatching it to avoid the Christmas Mail which can cause delays and disappearing tricks !!!



Thank you for your written confirmation together with your cheque for \$4,000 of the 6th. inst. which we received this morning.

We note that you wish your new guns to be built with a non automatic safety. This poses no problems however, we will supply you with the mechanism which will allow you to convert back to automatic if required in the future.

We confirm that your guns will be inlaid in gold 1 & 2 on the top levers, barrels breech and the tailpipes on the forends.

The length of a Powell forend is approximately seven inches. The side lock that you presently own may be fractionly longer at $7\frac{1}{2}$ inches ? We propose to make the forends on your new pair 7 inches which will aid the guns slim appearance.

We thank you for your stock measurements at:
 $1\frac{1}{2}$ - $2\frac{3}{4}$ " BEND. Cast off $\frac{1}{4}$ ". Single trigger length at $14\frac{1}{4}$ " equals a double trigger equivalent of $14\frac{5}{8}$ ".

We look forward to receiving your Holland & Holland in due course at the end of your Quail season.
