Thank you for your letter and check. We have gotten the Police & Thug revolver off to you and hope that it arrives without mishap.

We have three guns in stock that may be of interest to you. One of these you may have seen when you were here, I am not sure. It is a Colt Old Line .22 Open Top, factory engraved with pearl grips. Metal shows about 95% or more original nickel plate everywhere except on cylinder. Cylinder is clean, aged metal but shows no more than traces of finish. Cylinder is engraved in a pattern matching the balance of the gun. Grips are plain pearl and are excellent. \$125.00

We have just recently gotten a pair of Moore 1st Model Deringers that are in excellent condition. ~~Nickel~~ Nickel plate on the frames of these is about 90% to 95% intact with sharp, unworn engraving. The barrel of each gun shows small traces of original blue and metal is all very smooth and sharp with excellent markings. We would call them excellent in condition. They are just 20 numbers apart in serials - 4563 and 4583 and apparently were used as a pair. We have priced them at \$300 for the pair, but if you would like to buy one, we will offer it at \$150.

We do not have any factory engraved New Lines at this time. Thank you for writing and if we may serve you let us know.
