

P.S. The 22 New Line revolvers were numbered in one separate series starting at serial number one. First shipments were made in September 1873 and the last shipments in 1890.

Serial numbers ended in the 55,000 series and the highest number the writer has located to date is 55399. Since the barrel lengths are not listed in our shipping ledgers we are unable to tell you if these guns were made with other than the 2 1/4" barrel.
