Dear Sir,

Further to our letter of the 20th December we would first of all like to deal with the problems which arise if a private United States citizen wishes to import a gun from abroad, and remind you that under the new legislation it will be necessary for him to obtain an Import Certificate which is issued by the Alcohol & Tobacco Tax Department of the U.S.A. Treasury in Washington.

We understand that these are now being issued without much delay, and of course we would have plenty of time in which to obtain this if you favour us with your order.

We can supply a 20 gauge gun similar to the one purchased through the Sportsman's Den in Washington in accordance with the particulars enclosed herewith, but with extra barrels, and in accordance with the specification laid down by you, and the cost of this will be £500. 0. 0.

The gun case of the type required by you, specially fitted to take the extra pair of barrels will be £45. 0. 0d, and we would imagine that the weight of the gun would be in the neighbourhood of 5½ lbs if you so desire, but would point out that





- (a) The addition of a rubber recoil pad adds excessive weight
- (b) If you suffer from recoil the lighter the gun is the more recoil the shooter receives, but for such a calibre we do not feel that $5\frac{1}{2}$ lbs. excessive.

The time taken to make such a gun would be approximately six months and we trust that we will be favoured with your order.

Dear Sir,

We thank you for your letter of the 17th instant and confirm having received therein your instructions to proceed with the building of a 20 bore gun by Lang with two pairs of barrels, and for your information the specification is as follows:-

"Best quality boxlock hammerless ejector gun by Lang with double trigger, with two pairs of 26" barrels with $2\frac{3}{4}$ " chamber and concave rib, one pair bored right improved cylinder or 7 degrees of choke, left 15 degrees of choke, the extra barrels being bored right half choke left full choke. Half pistol grip stock to the following measurements:- bend $17/16$ " $1\frac{7}{8}$ ", cast off face $\frac{1}{8}$ ", bump $\frac{1}{4}$ ", toe $\frac{3}{8}$ ", length bump $15\frac{1}{4}$ ", centre $15\frac{1}{8}$ ", toe $15\frac{3}{8}$ ". Silver oval to be fitted and engraved "F.M.W." in script and the weight to be approximately 5 lbs. 8 ozs."

When finished the gun will be blocked into a best superior leather case to take both pairs of barrels and stamped in black "F.M.W." in script.

The date of delivery will be approximately July of this year and the number of the gun will be 20830.

The prices are as quoted in our letter of the 3rd instant, i.e. £500 or \$1,200.00 for the gun and £45 or \$ 108.00 for the case.

Since you ask in your letter of the 17th about any deposit required, our normal terms are 25% deposit on order and the balance paid when the work has been completed, and if this is agreeable to you we shall look forward to your cheque in due course.

With regard to the Import Certificate which you will now need to import the weapon, we fear that there is little that we can do here, and would advise you to make enquiries at your end at the appropriate Offices so that no time will be lost when the time for exporting is near.


Dear Sir,
