We appreciate the opportunity you have provided us to examine your gun.

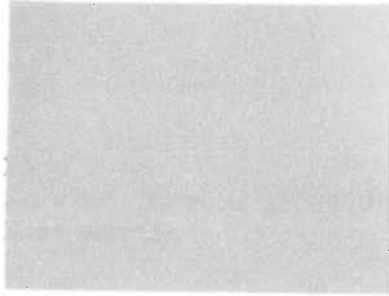
Our gunsmiths after carefully examining the gun advise the net charges for the repairs requested and found necessary would be as follows:

Clean and polish all parts	\$27.00
Furnish and fit new stock (skeet w/pad)	594.00
Furnish and fit new forearm	413.00
Extra polishing time before rebluing gun	81.00
Engrave	81.00
Reblue complete gun (including gold plating trigger)	200.00
Service charge	5.00
Return postage and insurance	6.00
TOTAL	\$1,407.00

Prior to 1974, some Browning guns were inadvertently stocked with wood which was improperly dried. It was found this could cause rusting under certain atmospheric conditions. By its very nature, however, the problem was quick to manifest itself to the purchaser. Our tests indicate the wood was improperly dried and will require replacement to eliminate rusting of the metal.

Also we would like to confirm that the lifetime guarantee applies only to the original owner of the gun registered with our Company. If you are the original owner and can forward the guarantee card to us, the above repairs will be performed at no charge.

If you are not the original owner, our special service policy on Superposed shotguns permits us to offer you a price reduction on the above quoted repairs. This special price would be \$532.00



rather than our normal quoted charge of \$1407.00. Understandably, this offer is made with the express stipulation that we retain possession of the damaged wood and all parts.

The time required to refurbish this gun would be approximately 4 to 6 months, due to the extensive amount of repairs and the complexity of the repairs.

We will continue to hold your firearm in our facility. If we receive no response to this letter within 60 days, we will assume that you prefer no work done and the firearm will be returned to you in the same condition as received by our company.

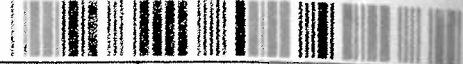
