Timeline

- Born April 10th 1895 at San Saba, Texas
- 1900 lived in Precinct #4 Menard county, Texas
- 1910 lived in Precinct #3 Crockett county Texas
- Colt SAA serial number 329867 ships to Sid June 17th, 1915
- 1917 Registers for US Army WWI in Clifton, Arizona
- 1917 August appears for physical examination for army rank of Pvt.
- 1919 - 1920 Rodeos in the Clifton, Arizona area
- 1920 lived in York, Greenlee county Arizona
- 1921 July mother commits suicide
- 1922 May commits train robbery
- 1922 July involved in shoot out with Bradbury brothers
- Johnnie Fulcher is killed and Sid is badly wounded
- 1922 July charged with train robbery
- 1925 November marries Frances Casta
- 1926 March Trial begins on train robbery charges
- 1926 April Convicted of train hold up and mail robbery with a 25 year sentence
- 1926 May Sid and Thomas Fulcher enter Leavenworth Federal Prison
- 1944 approx Sid and Thomas Fulcher are released from prison
- 1950 August Thomas Fulcher passes away
- 1951 Sept Sid Fulcher passes away from car accident in Clifton, Arizona
